HOMAI & HOMI MEHTA'S LEGACY

INDIAN ASSOCIATION OF SECRETARIES & ADMINISTRATIVE PROFESSIONALS



In 1965 Sir J.J. College of Commerce first set up a Secretarial Division to groom young girls to become Personal Secretaries.

Homai was then appointed as Faculty and Administrative Coordinator. Mr. Homi Mehta was appointed as Hon. Director.

Homai's professional competence and experience made her a member of National Secretaries Association (NSA) of USA.

In 1966 Mr. Homi Mehta was sent to USA, on a Lion's International Study Project to get familiarized with Business Education in USA. As a member of NSA, Homai managed to get Homi an invite to visit the headquarters of NSA in the United States. Upon his return to India, Homi got the idea of starting something like that in India too – a similar Association in India with chapters in different metros.

Homai then had the opportunity to visit the headquarters of NSA in Kansas, Missouri.

Homai and Homi Mehta then started working on the formation of National Institute of Personal Secretaries. (NIPS). They drafted the Memorandum and Articles of Association and got it registered as a Society with seven top Secretaries as Founder members. NIPS also got affiliated to NSA.

The Secretarial Division of Sir J.J. College also grew and the alumni got noticed and were employed in various top Corporates in Mumbai. To bring recognition to the Secretarial Profession, the College started an annual contest of “Miss Secretary” and an annual gala ball called “Fantastique Secretarial Nite”. Both these events were later given over to National Institute of Personal Secretaries.

The following ladies were the first Governing Council Members of the then National Institute of Personal Secretaries from October 1970 to 1972:

- 6) Mrs. Rhoda Vandrewala (Nee Mirza)
- 7) Late Mrs. Mehroo G. Sookhia

The first Annual General Meeting of the National Institute of Personal Secretaries was held on 23rd February 1972.

The rest, as they say, is history as known to one and all! Our own IASAP!

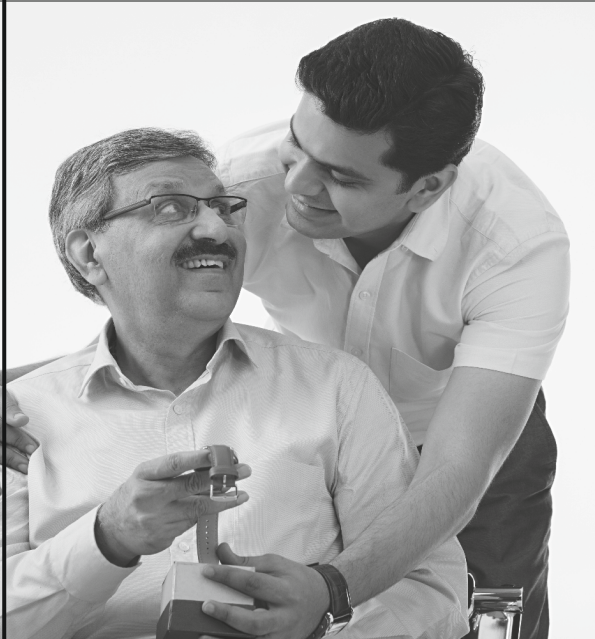

ABOUT ASA

The Association of Secretaries and Administrative Professionals in Asia Pacific (ASA), formerly known as The Association of Secretaries in Asia (ASA), was founded in 1974 in Manila by late Mrs. Virginia P. Elbinias, the then incumbent President of the Philippine Association of Secretaries & Administrative Professionals (PAS). ASA got its new name in September 1998 during the 13th Congress of Secretaries held in Bangkok in view of the United Nations definition that "Asia is a vast region, which includes Russia and the Pacific Rim countries". ASA's membership has enlarged to engulf New Zealand, Australia and the Pacific. ASA is affiliated to the International Association of Administrative Professionals (IAAP) with headquarters in Kansas City, USA. The formation of ASA has created a means for secretarial associations to network among members all over Asia and raises awareness of the importance of the profession.

At the ASA Congress, the "ASA Award" is bestowed on the All-Asia Winner. Indian Secretaries have won this prestigious Award in 1996, 1998, 2002 and 2008.

Mumbai hosted the 6th Congress of Secretaries in Asia in 1984 and had the privilege of hosting the 17th ASA Congress in Mumbai from November 11-15, 2006.

The main objectives of ASA are to :

- * Promote friendship, understanding and unity among the Secretaries in Asia
- * Promote professionalism
- * Encourage the establishment of secretarial associations in Asian countries
- * Encourage more countries to join ASA
